The undersigned Incorporators to these Articles of Incorporation, natural persons competent to contract, hereby forms a corporation under the laws of the State of Florida.

## **ARTICLE I.** CORPORATE NAME & ADDRESS:

The name of this corporation is:

#### **ARTICLE II.** NATURE OF BUSINESS AND POWERS:

The general purpose of this corporation shall be to transact in real estate and other lawful business transactions. The Corporation shall have all the powers enumerated in Florida Business Corporation Act, as the same now exists and as hereafter amended, and all such other powers as permitted by applicable law.
