

The undersigned subscribers to these Articles of Incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

**ARTICLE I – NAME**

The name of this corporation is RIVIERA YACHT CHARTER, INC.

The principal address is 3000 NW 48th Terrace, Ft. Lauderdale, FL 33313

**ARTICLE II – DURATION**

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

**ARTICLE III – PURPOSE**

This corporation is organized for the purpose of transacting any and all lawful business for which corporations may be incorporated under the Florida General Corporation Act.

**ARTICLE IV – CAPITAL STOCK**

This corporation is authorized to issue 2000 shares of Ten Dollar (\$10.00) par value common stock which shall be designated as "Common Shares".



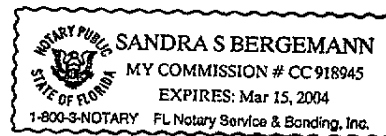
