ARTICLE I

The name of the corporation shall be Flag Facts, Inc.

ARTICLE II

The general nature of the business to be transacted by this corporation shall be sale of books regarding flags and all other activities permitted under the laws of Florida and the United States of America.

The officers of the corporation shall be elected by the Board of Directors of the corporation at a meeting to be held immediately following each annual meeting of the stockholders. 
