OF

ARTICLE I. NAME AND ADDRESS. The name of this corporation shall be Mitch K. C. Dee Apple, Inc. and its principal office address is: #7 Westward Drive, Miami Springs, FL 33166.

ARTICLE II. DURATION. This corporation is to exist perpetually.

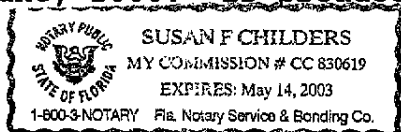
