**ARTICLES OF INCORPORATION  
OF

The undersigned, acting as incorporator of 251 Coconut Palm Road, Inc., under the Florida Business Corporation Act, adopts the following Articles of Incorporation:

**ARTICLE I**

**NAME**

**ARTICLE VII****INCORPORATOR**




