ARTICLE I

The name of the corporation is OLD RIVER PAINTBALL, INC.

ARTICLE II

This Corporation shall have perpetual existence, commencing as of the time these ARTICLES are filed by the Department of State, Division of Corporations.

ARTICLE III

This Corporation is formed to operate a paintball field and sales of paintball supplies. It shall also be empowered to transact and perform any and all lawful businesses for which corporations may be authorized under the Laws of the State of Florida.



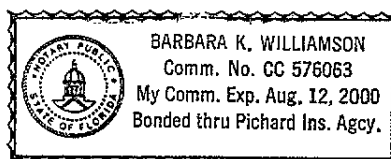


