

ARTICLE ONE - NAME

The name of this Corporation shall be **ACME CONCRETE PUMPING, INC.**, with its principal place of business located at **18405 Turning Place, Hillsborough County, Florida.**

ARTICLE TWO - DURATION

The Corporation shall have a perpetual existence, commencing on the date of filing.

ARTICLE THREE - PURPOSE

The Corporation is organized for the purpose of operating a concrete pumping business; to provide services in all phases of general construction, repair and erection of buildings and similar structures; and to engage in any other activity or business permitted under the laws of the United States and the State of Florida, or necessary to carry out the purposes herein.

ARTICLE FOUR - CAPITAL STOCK

The Corporation is authorized to issue five hundred (500) shares of common stock having a par value of one dollar (\$1.00) per share.

ARTICLE FIVE - INITIAL REGISTERED OFFICE AND AGENT

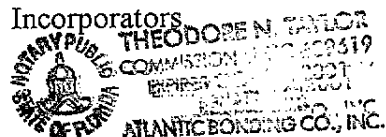




