**ARTICLES OF INCORPORATION  
OF  
MEDICINE MAN'S CORNER, INC.**

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

**ARTICLE I - NAME**

The name of the Corporation ("Corporation") is Medicine Man's Corner, Inc.

**ARTICLE II - POWERS**

The Corporation shall have the power to engage in any lawful activity for which corporations may be organized under the Florida Business Corporation Act.

**ARTICLE III - STREET ADDRESS OF PRINCIPAL OFFICE**

The street address of the principal office of the Corporation is 2063 North Monroe Street, Tallahassee, Florida 32303.

**ARTICLE IV - AUTHORIZED NUMBER OF SHARES**

The maximum number of shares this Corporation is authorized to issue is 1000, par value \$.10 per share, all of which shall be Common Shares. All Common Shares shall be identical with each other in every respect and the holders of Common Shares shall be entitled to one vote for each share on all matters on which shareholders have the right to vote.
