NAME

The name of this corporation is: BoNe Imaging, Inc.

ARTICLE 2

DURATION

The number of directors may be changed from time to time in accordance with the bylaws.



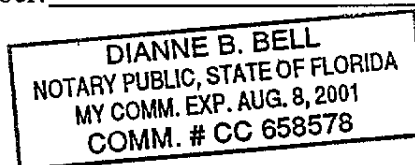
