The name of this corporation is: ALLSAFE MOVING SERVICES, INC."

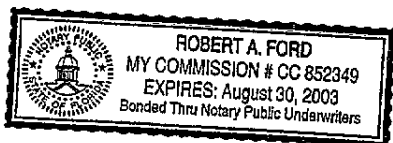
