ARTICLE III - NATURE OF BUSINESS

This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Florida, or any other state, county, territory or nation. However, the purpose for which this corporation is organized shall be for sewer and drain cleaning.

ARTICLE IV - TERM OF EXISTENCE

This corporation shall exist perpetually.

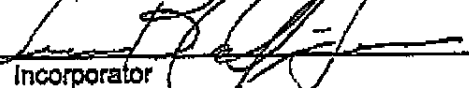
