
ARTICLE IX

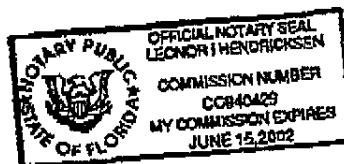




