**ARTICLE I - Name**

The name of the corporation shall be: **SANTE DESIGN CUSTOM PAINTING, INC.**

**ARTICLE II - Duration**

This corporation shall exist in perpetuity commencing on the date of execution and acknowledgment of these Articles.

**ARTICLE III - Purpose**

This corporation is organized for the purpose of transacting any and all lawful business, including, but not limited to the following: Painting, decorative finish, tile, drywall texture, landscape sculptures and related services.

**ARTICLE IV - Capital Stock**

This corporation is authorized to issue One Thousand (1,000) shares of Ten Cents (.10) par value common stock which shall be designated "Common Shares."

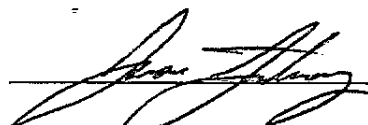

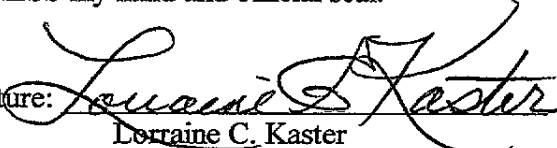

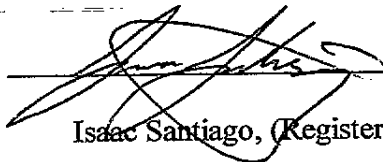
