ARTICLE I. NAME

The name of this corporation shall be West Orange Automotive, Inc..

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation with the Florida Department of State, Division of Corporations. This corporation's duration shall be perpetual.
