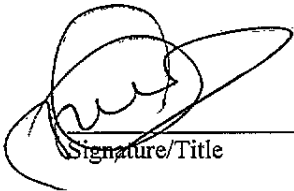
ARTICLE IX - BY LAWS

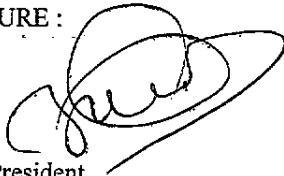
