The undersigned incorporator, for the purpose of forming a corporation under the Florida General Corporation Act, hereby adopts the following Articles of Incorporation:

ARTICLE I - NAME

The name of this Corporation is MEDTA CORPORATION and its address is 205 SW 135TH Avenue, Miami, FL 33184.

ARTICLE II - DURATION

This Corporation will have perpetual existence.

ARTICLE III - NATURE OF BUSINESS

This Corporation may engage in or transact any or all lawful activities or business permitted under the laws of the United States of America, the State of Florida or any other state, country, territory or nation.

ARTICLE IV - CAPITAL STOCK

This Corporation is authorized to issue 1,000 (one thousand) shares of common stock of \$1.00 (one dollar) par value.

ARTICLE V - PREEMPTIVE RIGHTS

Every shareholder upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, will have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the price that it is offered to others.

ARTICLE VI - INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of this Corporation is 205 SW 135th Avenue, Miami, FL 33184 and the name of the initial registered agent of this Corporation is Tania Mederos.

ARTICLE VII - INITIAL BOARD OF DIRECTORS

This Corporation will have one (1) Director initially. The number of Directors may be either increased or decreased from time to time by the Bylaws, but will never be less than one (1). The names and addresses of the initial Director of this Corporation is as follows:

This Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation, in accordance with the provisions of the Florida Business Corporation Act.


