## ARTICLES OF INCORPORATION

OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

## ARTICLES ONE: NAME

The name of this corporation shall be: **GULF COAST STORAGE BUILDINGS**, **INC**.

# ARTICLE TWO: NATURE OF BUSINESS

The general purpose for which this corporation is initially organized is to own and operate a business for the retail sale of storage buildings, and for the further purpose of engaging in any activities or business permitted under the laws of the United States and Florida.
