#### Article X - Indemnification

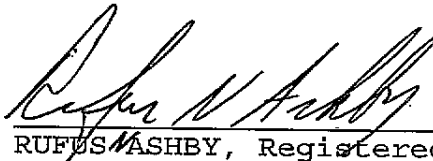
The corporation shall indemnify any officer or director, or any former officer or director, to the full extent permitted by law.

#### Article XI - Amendment

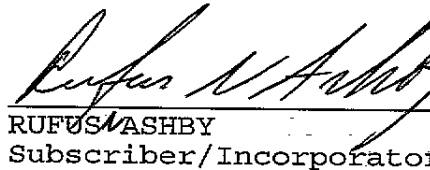

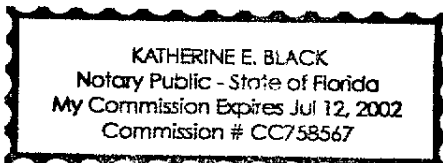

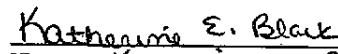
