**ARTICLES OF INCORPORATION
OF
SEGUROSDIRECT OF FLORIDA, INC.**

ARTICLE I - Name

The name of the corporation is SegurosDirect of Florida, Inc. (hereinafter referred to as the "Corporation").

ARTICLE II - Purpose

The Corporation is organized for the purposes of engaging in any lawful act or activity for which corporations may be organized under the laws of the State of Florida.

ARTICLE III - Capital Stock

The par value thereof and the characteristics of such stock shall be as follows

- (a) Number of shares authorized is 1,000.
- (b) Par value per share is .01.
- (c) Class of stock is common.

ARTICLE IV - Initial Registered Office and Agent
