

ARTICLES OF INCORPORATION
OF

ARTICLE I - NAME

The name of this Corporation is : Classic Tree Service of Vero, Inc.

ARTICLE II - DURATION

The Corporation shall have a perpetual existence.

ARTICLE III - PURPOSE

The purpose of this Corporation is to engage in any activities or business under the laws of the United States and Florida.

ARTICLE IV - CAPITAL STOCK

The maximum number of shares which this Corporation is authorized to have outstanding at any time is:

5,000 shares of Common stock having a par value of



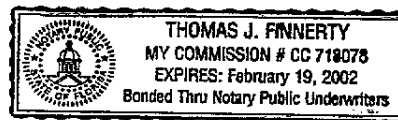
