The undersigned incorporators to these Articles of Incorporation, natural persons competent to contract, hereby subscribe and form a corporation for profit under the Laws of the State of Florida.

**ARTICLES I - NAME**

The name of the corporation is SQUIRREL'S NEW & USED OFFICE FURNITURE, INC.

**ARTICLE II - NATURE OF BUSINESS**

The corporation may engage in any activity or business permitted under the laws of the United State and of the state of florida, including, but not limited to: WHOLESALE AND RETAIL SALE AND SERVICE OF NEW & USED OFFICE FURNITURE; MANUFACTURING AND ASSEMBLING OF OFFICE FURNITURE; TRUCKING, CARTAGE, IMPORTING AND EXPORTING OF NEW AND USED OFFICE FURNITURE;

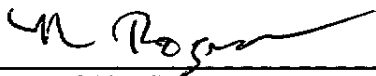

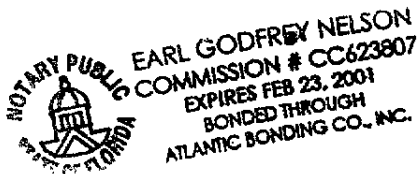
