INDEMNIFICATION

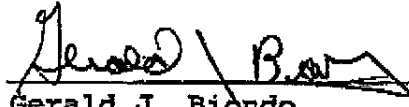

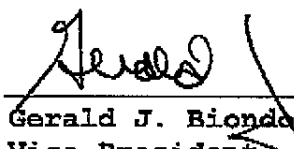
