The undersigned Incorporator to these Articles of Incorporation does hereby adapt the following articles of Incorporation under the laws of the State of Florida.

**ARTICLE I - NAME.** The name of this Corporation is BAY PAINT TECHNOLOGY, INC.

**ARTICLE II - DURATION.** This Corporation shall have perpetual existence unless dissolved according to law.

**ARTICLE III - BUSINESS.** This Corporation is organized for the purpose of transacting any and all lawful business or businesses permitted to any corporation under the laws of the State of Florida pursuant to the Florida General Corporation Act.

**ARTICLE IV - PRINCIPAL OFFICE.** The address of the principal office of this corporation is 1308 Costa Mesa Dr, Wesley Chapel, FL 33543, which shall also serve as the mailing address of the Corporation.

**ARTICLE V - CAPITAL STOCK.** The capital stock of this Corporation shall consist of one (1) class to be known as common voting stock. The maximum number of shares of stock authorized to be issued by this Corporation is one million (1,00,000) shares of capital stock of the par value of One Dollar (\$1.00) each, all of which shall have the same rights and privileges.

**ARTICLE VII - INITIAL REGISTERED OFFICE AND AGENT.** The street address of the initial registered office of this Corporation and the name of the individual registered agent of this ANDRE L GILL, 1308 COSTA MESA DR, WESLEY CHAPEL, FL 33543. The corporation shall have the privilege of establishing such other branch offices in any other location or any other city or town in this state any other state or country, as may be approved by its Board of Directors.


