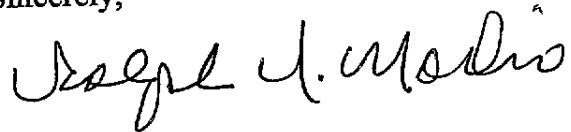

AMENDMENT**

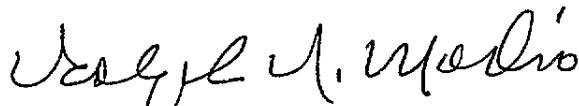
