ARTICLE I. NAME: The name of the corporation is SIMISON CONSTRUCTION, INC.

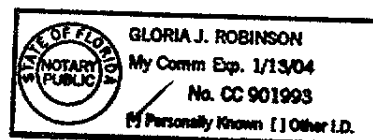


