Article I - Name

The name of this Corporation is:

Article II - Principal Office and Mailing Address

The principal office and mailing address of the Corporation shall be:

Article III - Duration

This Corporation shall have perpetual existence, commencing on the date of filing of these Articles.

Article IV - Purpose

This Corporation is organized for the purpose of engaging in the provision of services; in the import, export, purchase and sale of wholesale and retail goods; the creation, recording and production of musical entertainment and recordings and in any other business permitted by law.

Article VII - Rights of Shareholders

Article VIII - Preemptive Rights

Every shareholder, upon the sale of any new stock of this Corporation of the same class or series as that which he already holds, shall have the right to his Pro-rata share thereof as nearly as may be done without the issuance of fractional shares at the price and under terms which said new shares are offered to others, said rights to be limited only as set forth in F.S. 607.0630.


