

ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of this corporation is Edie Buckius, Inc.

ARTICLE II - DURATION

This corporation shall have perpetual existence commencing on the date of this filing of these Articles with the Department of State.

ARTICLE III - PURPOSE

This corporation may engage in or transact any or all lawful activities or business under the laws of the United States, the State of Florida, or any other state, country, territory or nation.

ARTICLE IX - INDEMNIFICATION


The corporation shall indemnify any officer or director, or former officer or director, to the full extent permitted by law.
