ARTICLES OF INCORPORATION

OF

GLOBAL CONCEPTS INTERNATIONAL, INC.



The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I- CORPORATE NAME

The name of the corporation shall be: GLOBAL CONCEPTS INTERNATIONAL, INC.

ARTICLE II - DURATION

This corporation shall exist perpetually unless dissolved according to Florida Law.

ARTICLE III - PURPOSE
