ARTICLES OF INCORPORATION OF

BOX OF FROGS INTERNATIONAL HOLDINGS, INC.

The undersigned, acting as incorporator of a corporation pursuant to Florida Statutes, hereby adopts the following Articles of Incorporation:

ARTICLE I

The name of the corporation shall be BOX OF FROGS INTERNATIONAL HOLDINGS, INC.

ARTICLE II

The corporation shall exist perpetually and for an indefinite period.
