ARTICLE 1

Corporation Name

The name and address of this corporation shall be: **Bowyer Surveying & Mapping, Inc.** , 4460
N.W. 19th Way, Oakland Park, Fl. 33309

ARTICLE 2

Nature of Business

The general nature of business and the proposed objects and purposes to be transacted, promoted and carried on by the corporation are to do any and all things hereinafter mentioned as fully and to the same effect and extent as natural persons might or could do under the laws of the State of Florida, viz.,

1. To engage in all aspects of the Surveying and Mapping profession allowable within this State.
2. To invest its funds in real estate, mortgages, stock bonds and any other type of investments permitted by law.
3. To own real and personal property necessary for the rendering of the professional services hereby authorized.
4. To engage in no other business other than the rendering of the professional services specified herein.

ARTICLE 3

Capital Stock

1. The maximum number of shares of stock that the corporation is authorized to have outstanding at any one time shall be one thousand shares of common stock with One Dollar (\$1.00) per share par value.
2. The consideration to be paid for each share shall be payable in lawful money of the United States of America, or in property, labor or service which, in the judgment of the Board of Directors of this corporation, shall be of the valuation equivalent to value of the stock.
3. Shares of the corporations stock and certificates therefore shall be issued only to individuals approved by the board of directors.

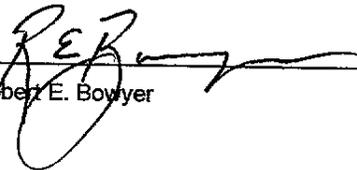
ARTICLE 9

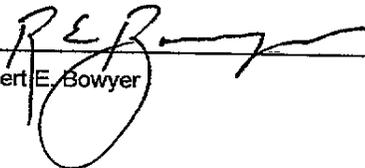
