**ARTICLE I - NAME**

**ARTICLE II - PRINCIPAL PLACE OF BUSINESS**

The principal place of business of this corporation shall be:


**ARTICLE X - INDEMNITY**

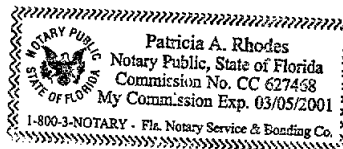
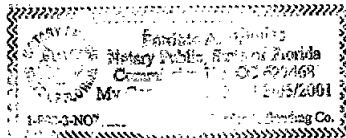
