The undersigned subscribers of these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

ARTICLE I. NAME

The name of this corporation is:

ARTICLE II. NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation is REAL ESTATE BROKERAGE

ARTICLE III. CAPITAL STOCK
