The name of the corporation shall be JODI ANDERSON, P.A.

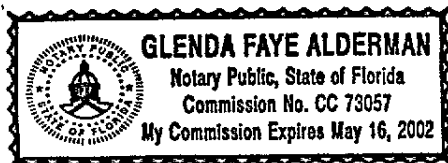
