**ARTICLES OF INCORPORATION
OF

I, the undersigned Incorporator, for the purpose of forming a corporation under the laws of the State of Florida, do hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is:

ChemTek Translations, Inc.

The Principle place of business of this corporation shall be 684 Venture Court, Winter Springs, Florida 32708.

ARTICLE II

This Corporation is organized for the purpose of engaging in translation of documents and to engage in any activity permitted under the laws of the United States and the laws of the State of Florida.

The Corporation shall do everything necessary and proper in accomplishing the purposes set forth above and to do anything incidental thereto which is not forbidden under the laws of the United States and the State of Florida.

ARTICLE III

The maximum number of shares of stock that this Corporation is authorized to have outstanding at ant time is 1000 shares of common stock having a nominal or par value of \$1.00 per share. Shares of the Corporation's stock shall be issued only in compliance with subchapter S of the Internal Revenue Code regarding corporations.

ARTICLE IV

The Corporation shall have a perpetual existence.

ARTICLE V

The street address of the initial registered office of the corporation is 684 Venture Court, Winter Springs, Florida 32708 and the name of the initial registered agent is Donna Lenahan.

ARTICLE VI

The corporation shall indemnify any officer or director or any former officer or director, to the full extent of the law.


ARTICLE X




DESIGNATION OF REGISTERED AGENT
