ARTICLES OF INCORPORATION OF SCOTT CLEANING SERVICES OF KISSIMMEE, INC.

THE UNDERSIGNED, acting as sole incorporator of SCOTT CLEANING. SERVICES OF KISSIMMEE, INC. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

ARTICLE I NAME

The name of the corporation is SCOTT CLEANING SERVICES OF KISSIMMEE, INC.

ARTICLE II SHARES

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, one cent (\$.01) par value per share.
