
## ARTICLES OF INCORPORATION

OF

### ARTICLE 1. - NAME

The name of the Corporation is Buckron Tops, Inc..



### **ARTICLE 2. - PRINCIPAL OFFICE**

The principal office of the Corporation shall initially be at 484 Horseshoe Loop Road, P.O. Box 472, Terra Ceia, Florida 34250. The Corporation may change its principal office from time to time as permitted by law.

### ARTICLE 6. - SHARES [CAPITAL STOCK]
