I, the undersigned subscriber to these Articles of Incorporation, a natural person, competent to contract, do hereby announce my intent to form a corporation for profit under the laws of the State of Florida.

ARTICLE I

The name of this corporation shall be and is:

E-Z RIGGING, INC.

ARTICLE II

The duration of the corporation is perpetual.

ARTICLE III

The principal office of this corporation is located at 150 Lynn Drive, Santa Rosa Beach, Florida 32459.

ARTICLE IV

The general purposes for which the corporation is organized are:

1. To manufacture and sell at both retail and wholesale cantilevered scaffolding and other devices and equipment to be

2. 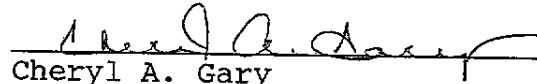
