**ARTICLE I – NAME**

The name of the corporation is **CREATIVE CASUALS, INC.**

Pursuant to Chapter 48.091, Florida Statutes, the following is submitted in compliance with said Act:

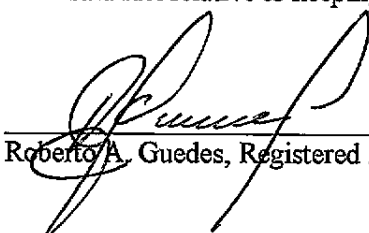
