#### ARTICLES OF INCORPORATION

The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract, hereby forms a corporation under the laws of the State of Florida. Ola 28/02

# **ARTICLE I - NAME**

The name of this corporation is O'BANNON AIR, INC.

#### <u>ARTICLE II - DURATION</u>

The existence of this corporation is to begin at the time of subscription and acknowledgement of incorporation and to continue perpetually thereafter.

#### <u>ARTICLE III - PURPOSE</u>

The corporation is organized for the primary purpose of engaging in the business of sales and service of air conditioning units. In addition, this corporation may engage in every phase of any and all activities or businesses permitted by laws of the United States and of the State of Florida or any other state, territory, district, or possession of the United States and all such activities or businesses as may be permitted in any foreign country.
