
In accordance with instructions received from one of your staff members during a telecon about noon today (January 16, 2004), the undersigned President (Charles E. Baker) of E. Baker Concrete, Inc. (59-3661024) is sending a \$600.00 check in full payment of corporate reinstatement through CY 2004.

We apologize for failure to pay four \$150.00 annual report fees in a timely manner. Our previous accountant incorporated our business on July 3, 2000, but did not notify us that a 2001 annual report fee (\$150.00) was due by May 1, 2001. Moreover, we do not recall receiving any annual report renewal forms for CY 2001, 2002, 2003 or 2004. When, we contacted a new accountant on January 15, 2004, his staff queried the internet and found that our business was incorporated on July 3, 2000 and administratively dissolved on September 21, 2001 for non-payment of the annual report fee. 
We thank you for your consideration in this matter. Furthermore, we promise to submit timely annual report fee payments in the future.
