ARTICLES OF INCORPORATION
OF

The undersigned subscriber to these Articles of Incorporation, Gerald J. Segal, being a natural person competent to contract, hereby acknowledges and files these ARTICLES OF INCORPORATION in the Office of the Secretary of State of the State of Florida in order to form a Corporation for profit under the laws of the State of Florida.

ARTICLE I

CORPORATE NAME

The name of this Corporation is SEGAL INITIATIVES, INC. The principal office and mailing address of the corporation is 9590 Victoria Lane, #106, Naples, Florida 34109.

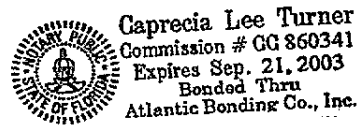
