The street address of the corporation's initial registered office and the name of its initial registered agent at such addresses is:





Any director or officer who is involved in litigation or other proceeding by reason of his or her position as a director or officer of this corporation shall be indemnified and held harmless by the corporation to the fullest extent permitted by law.
