# ARTICLE I

Name. The name of this corporation is EHS HOSPITALITY GROUP OF FLORIDA, INC.

# ARTICLE II

Duration. The corporation shall be perpetual.

# ARTICLE III

<u>Purpose</u>. This corporation is organized for the purpose of transacting any or all lawful business.
