ARTICLES OF AMENDMENT TO  
ARTICLES OF INCORPORATION

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Corporation adopts the following articles of amendment to its Amended and Restated Articles of Incorporation:

1. The name of the Corporation is **Newton Financial Services, Inc.** (the "Corporation").

2 Article I of the Amended and Restated Articles of Incorporation is amended to read in its entirety as follows:

**"Article I - Name**

The name of the corporation is changed from Newton Financial Services, Inc. to Hurst Technologies, Inc.

3. The foregoing amendment was adopted unanimously by the directors of the Corporation and its sole shareholder by written action dated July 13, 2000.
