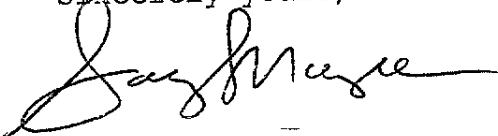

ARTICLE I

The name of this corporation shall be **SCRS, INC.** and its principal place of business shall be 10258 RIVERSIDE DRIVE, UNIT 4, PALM BEACH GARDENS, FL 33410.

ARTICLE II

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

ARTICLE III

The maximum number of shares of capital stock which the corporation is authorized to have at any time is ONE HUNDRED (100) shares of common stock at \$1.00 par value.

ARTICLE IV

The corporation shall have perpetual existence.

ARTICLE V

designation agrees to comply with the provisions of Sections 48.091, Florida Statutes as amended from time to time, with respect to keeping an office open for service of process.


ARTICLE VI
