ARTICLES OF INCORPORATION OF

GUARANTEED RELIABLE COMMUNICATIONS, INC.

ARTICLE I-Name

The name of this corporation is Guaranteed Reliable Communications, Inc.

ARTICLE II- Principal Office

The address of the principal office is 4400 Selah Road, Sebring, Florida 33872.

ARTICLE III-Duration

This corporation shall have perpetual existence.

ARTICLE IV-Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE V-Capital Stock

This corporation is authorized to issue Eight Thousand (8,000) shares of One Dollar (\$1.00) par value common stock which shall be designated "Common Shares".
