

ARTICLE I. NAME AND ADDRESS

The name of this corporation is MilRose Court Reporters, Inc., and the address of the corporation shall be 2202 North Westshore Boulevard, Suite 200, Tampa, Florida 33607.

ARTICLE II. COMMENCEMENT OF CORPORATE EXISTENCE

In accordance with Section 607.167 Florida Statutes, the date when corporate existence shall commence is the date of subscription and acknowledgment of these Articles of Incorporation.

ARTICLE III. DURATION

This corporation shall exist perpetually, commencing on the date of the subscription and acknowledgment of the Articles of Incorporation.

ARTICLE IV. PURPOSE

This corporation is organized for the purpose of the transaction of any lawful business.

ARTICLE V. CAPITAL STOCK

This corporation is authorized to issue one million common shares of \$.001 (dollars) par value capital stock.


ARTICLE X. INDEMNIFICATION

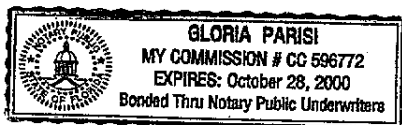


