ARTICLES OF INCORPORATION

OF

The undersigned, for the purpose of forming a corporation, adopts the following Articles of Incorporation:

ARTICLE I

NAME

The name of the corporation is Palm Beach Chiropractic & Pain Rehabilitation Center, Inc., and its address is 19173 Cloister Lake Lane, Boca Raton, Florida 33498.

ARTICLE II

DURATION

The duration of the corporation is perpetual.

ARTICLE III

PURPOSES


