

On October 2, 2001, I forwarded to you a Statement of Change of Registered Agent for the above-referenced corporation, along with a check in the amount of \$35.00 to cover the filing fee. I am in receipt of your letter dated October 31, 2001, wherein the document was not filed and returned because the corporation was administratively dissolved for failure to file its 2001 corporate annual report. For ease of reference, I have enclosed a copy of that letter. My client did not receive an annual report form for this corporation, and did not notice that it had not received the form.
