The undersigned, acting as incorporator, hereby adopts these Articles of Incorporation and forms a for profit corporation (the "Corporation") under the laws of the State of Florida, as follows:

1. NAME

The name of this corporation is:

2. TERMS OF EXISTENCE

3. PURPOSE

The purpose for which this corporation is organized is to transact any and all business for which a corporation may be incorporated under Florida laws, including the ownership and operation of real property.

The initial Board of Directors shall consist of one member whose name and address is as follows:

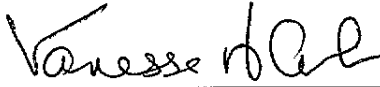

7. INCORPORATOR

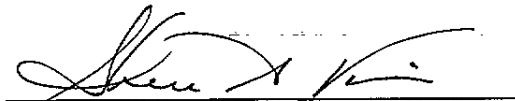

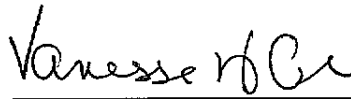
